

# SAN JOSE UNIFIED SCHOOL DISTRICT KINDERGARTEN PRE-REGISTRATION FOR 2010-11

**APRIL 1, 2010\***

## IMPORTANT INFORMATION

To register your child, please bring the following:

1. Parent or Guardian Picture I.D.
2. Proof of your child's birthdate: Birth Certificate/ Passport (Student must be born on or before December 2, 2005)
3. Three current proofs of address listed under parents/guardian name dated within the past 60 days (3 Documents: i.e. PG&E. Cable TV bill; Governmental Document; Telephone Bill; Car Insurance, etc.)
4. Immunization Record - A written up-to-date immunization record must be provided.

	Kindergarten Requirements
<b>Polio</b>	<b>4 doses</b> at any age, but <b>3 doses</b> meet requirement if at least one was given on or after the 4 <sup>th</sup> birthday** ( <i>California Health and Safety Code §120325-120380</i> ).
<b>DTP, DTaP</b>	<b>5 doses</b> at any age, but <b>4 doses</b> meet requirements if at least one was on or after the 4 <sup>th</sup> birthday** ( <i>California Health and Safety Code §120325-120380</i> ).
<b>MMR</b>	<b>2 doses</b> , (one must be an MMR, the other may be a measles only vaccine) both must have been given on or after 1 <sup>st</sup> birthday** ( <i>California Health and Safety Code §120325-120380</i> ).
<b>Hepatitis B</b>	<b>3 doses</b> . If not complete, must be up-to-date ( <i>California Health and Safety Code §120325-120380</i> ).
<b>Varicella (chicken pox)</b>	<b>1 dose</b> or <i>health care provider-documented</i> varicella disease or immunity ( <i>California Health and Safety Code §120325-120380</i> ).
<b>Mantoux Tb skin test</b>	Must be given <i>and read</i> on or after March 1, 2009. TB test results must be complete at time of enrollment. Only TB tests given in the United States will be accepted. Tests given, but not read 2-3 days later, must be repeated. Tine Tb tests are not accepted. ( <i>Santa Clara County School TB Mandate</i> ).

**\*Note:** Kindergarten parents can select their attendance boundary school, a magnet school or if appropriate make a voluntary transfer that will aid the district Voluntary Integration Plan. Initial **Enrollment Period** for Elementary Magnet Schools (Hacienda, Hammer at Galarza and River Glen) **ends on May 05<sup>th</sup>, 2010**. Capacity permitting, all Kindergarten students are assured their attendance boundary school.
